Counselor Education - to teach introductory courses; advanced courses; Ph.D. level courses; and field placement courses. Courses meet once weekly (M-Th 4:30 PM and/or 7:30 PM at the Union campus; Kean Ocean offers weekend courses and some weekday evening courses.) Courses are assigned based on departmental needs. Additional requirements include: licensure as an LPC, with ACS preferred or school counselor certification required to teach field placement courses. A Ph.D. in Counseling is required to teach doctoral level courses. Courses are to be taught in-person at both the Union and Ocean campus.

All adjunct positions require a Master's degree in a related field and teaching experience unless otherwise indicated; candidates with an ABD, Ed.D., Ph.D. or other acceptable disciplinary doctorate are encouraged to apply. Proficiency in a Learning Management System is required, consistent with University guidelines.

Please submit cover letter (indicating availability for days, evenings or weekends, campus location of Union or Ocean), resume and contact information for three professional references. Review of applications will begin immediately and be on-going. Official transcripts are required before appointment.
